WAR DOG SAFE

LIMITED LIFETIME WARRANTY

TO THE PURCHASER (NON-TRANSFERABLE)

- 1. War Dog Safes warrants all new products to be free from defects in material and workmanship at the time of shipment.
- 2. In the event of any metal or structural casing defect, the damaged \ defective part(s) will be replaced without charge for part(s) or labor, by this **Limited Lifetime Warranty** under the following conditions only:
 - a) That the damage was sustained under normal use and service and was not due to exterior influences or operations beyond capacity.
 - b) That the products covered by this warranty were used only in conjunction with War Dog Safe approved parts.
 - c) That the Purchaser gives War Dog Safe immediate written notice of such damage \ defect or defects, and that all faulty parts or equipment are returned to War Dog Safe with prior authorization from War Dog Safe.
 - d) Any alteration or repair by others in such a manner as in War Dog Safe's judgment materially and adversely affects the product shall void this warranty.
 - e) That the method of shipment for any replacement part will be regular ground at War Dog Safe expense, with the carrier being determined by War Dog Safe. Customer requests for alternate carriers for shipment of replacement parts, will be at the customer's expense unless approved by War Dog Safe.
- 3. With respect to the **ELECTRONIC COMBINATION CONTROLLER \ BIOMETERIC KEYPAD** and associated mechanical \ electrical circuitry, the warranty shall be for a period of **(ONE YEAR)**, subject to the same conditions listed in Item 2. After the first year, the shipping and installation costs will be the responsibility of the customer.
- 4. War Dog Safe's obligation under this warranty is expressly limited to the replacement obligations set forth in Paragraphs 2 and 3, in accordance with the stipulations set forth in this warranty. War Dog Safe's obligation under this warranty shall not include any transportation charges or cost of installation or any liability for special, direct, indirect, or consequential damages of delay. Correction of nonconformities, in the manner provided above, shall constitute fulfillment of all liabilities of War Dog Safe, whether based on contract, negligence or otherwise with respect to, or arising out of such products. In no event, whether in contract, in tort, under any warranty, or otherwise including, without limitation, the negligence of the company, its employees or agents, shall War Dog Safe be liable for any damages beyond the price of the faulty or defective parts and equipment.
- 5. No person, company or corporation is authorized to assume for War Dog Safe any other liability in connection with said products. Under no circumstances is War Dog Safe liable for damage resulting from faulty or improperly installed equipment or from misapplication beyond normal intended use of said equipment. There shall be no third party beneficiary to any warranties set forth herein. This constitutes the only warranty of the company and no other warranty or condition, statutory or otherwise shall be implied.
